The Panchayat at the village level is usually called Gram Panchayats; the Panchayat at the Block or Tehsil level is usually called Panchayat Samiti or Block Samiti; and the Panchayat at the district level is usually called Zila Parishad. However, the names of Panchayats at the three levels may vary from State to State.

Nature of Pardoning Powers

It is an executive power exercised by the President on the aid and advice of the Council of Ministers. Thus, it is not a discretionary power of the President.

Moreover, Union executive does not arrange a Court of appeal while listening to pardoning matters. Thus, the petitioner has no right of oral hearing before the Union Executive. The petition for seeking pardon is submitted in form a file. Union executive usually Home Ministry takes the decision on the submitted file.

Most of the pardoning petitions filed with the President pertain to revocation of death penalty. President does not need to specify reasons for granting or refusing pardon.

Speaker In India and United Kingdom

In the United Kingdom, the convention of 'once a speaker, always a speaker' is followed. As soon as the Speaker is appointed in the UK, there is a convention that the Speaker has to resign from the political party. Thus, the Speaker of House of Commons (equivalent to Lok Sabha in India) is a non-party person. This convention helps Speaker in maintaining his independence and impartiality.

However, the resignation from the parent political party act against the political career of the speaker as he would not get the support of the parent political party in the next elections. In order to overcome this limitation. Speaker can contest the next elections and, in such elections, he is unopposed by the major political parties, including the original party of which he was member. The major political parties do not field candidate against the Speaker. Thus, the Speaker's constituency virtually remains unchallenged in the election. Therefore, it is easier for the Speaker to get elected again to the house as member. After being elected as member, since the person has prior experience of serving as Speaker and is already a non-party person, he is often considered by members of the house for being elected as Speaker. Thus, the convention of not fielding candidate against the Speaker in the elections is called 'once a speaker, always a speaker'.

However, in India, it depends upon the speaker itself. The Speaker may or may not resign from his political party. Thus, the convention of Speaker resigning from political party is not firmly established in India. It is to be noted that if Speaker decides to resign from political party, he is not disqualified under anti-defection law.

And why did the court find that states have the power to tax 'mineral development'?

The second aspect that the court considered was whether states have the power to tax mineral development activities, or whether such taxes are the sole province of the Centre under the MMDRA. This friction can be traced to the Seventh Schedule of the Constitution.

Under the State List, states are given the exclusive power to make laws relating to "Taxes on mineral rights subject to any limitations imposed by Parliament by law relating to mineral development" (Entry 50). However, Entry 54 of the Union List gives the Centre the power over "Regulation of mines and mineral development to the extent to which... is declared by Parliament by law to be expedient in the public interest".

According to the India Cement position, the royalty collected by state governments under the MMDRA would be in the form of a tax which "covers the field", barring any further taxes from being imposed. However, the court in Mineral Area Development Authority held that royalty is not a tax. As a result, "royalty would not be comprehended within the meaning of the expression 'taxes on mineral rights'" (under Entry 50 of the State List). Effectively, the court held that the MMDRA only gives states another revenue stream through royalties, and does not interfere with states' powers to impose taxes under Entry 50.

The court also held that Parliament's powers under Entry 54 of the Union List do not extend to imposing taxes, as that power exclusively rests with state legislatures. However, Entry 50 allows Parliament to place "any limitations" on states' power to impose taxes, which the court held "may include even a 'prohibition'" against imposing taxes.

The court did not limit states' power to tax mineral development activities to Entry 50, though. It held that the state also had the power to tax the land where mines and quarries are located as it includes "(i) all types of lands; and (ii) covers everything under or over land". These taxes, the court held, "will not be affected by the MMDR Act".

Interstate council

Art. 263 authorizes President to establish interstate council to secure coordination among states and between Centre and states.

President can define the nature of duties to be performed by such council and also organization and procedure of such council. secretariat of zonal councils.

Zonal Councils

These are statutory (and not constitutional) bodies as they were created under Parliamentary law. Five Zonal Councils were created under States Reorganization Act, 1956, namely, Northern, Southern, Eastern, Western, and Central Zonal Council. A separate North-East Zonal Council was created in 1971.

Zonal Councils also act as deliberative and advisory bodies on National integration, Law and order, Execution of development projects, Exchange of ideas, and so on.

The composition of each Zonal Council is as follows:

- (a) Union Home Minister is the chairperson
- (b) Chief Ministers of all states in the zone.
- (c) Two other ministers from each state in the zone.
- (d) Administrator of each Union Territory in the zone.

However, the composition of North East Council is different.

Though President can define nature of duties of such council, Art. 263 specifies that duties of following types can be assigned to the council:

- 1. Advising upon disputes which may arise between states
- 2. Discussing matters in which states or center and the states have common interest.
- Recommendations for coordination of policy and action among various states.

Under provisions of Art. 263, President has established Central Council of Health and Family Welfare, Central Council of Local Government and others.

In 1990, Central Government established interstate council dealing with general issues and it was named as Inter-Governmental Council to differentiate it from other councils established under Art. 263.

Composition of Inter-Governmental Council:

- (a) Prime Minister as Chairperson
- (b) Six cabinet ministers including Union Home Minister
- (c) Chief Ministers of all states and Union Territories
- (d) Administrator of Union Territories

The council is expected to meet at least thrice a year. There is also a standing committee associated with the As per the provisions of the North Eastern Council (Amendment) Act, 2002, the North Eastern Council shall consist of the following members:

- (i) Governors of States
- (ii) Chief Ministers of States
- (iii) three members to be nominated by the President

Home Minister of India is not a member of North-East Council.

Council of Ministers to aid and advise Governor (Art. 163)

As per Article 163 (1), there shall be a Council of Ministers headed by chief Minister to aid and advise the Governor in the exercise of his functions, except when he is required to exercise the functions in his discretion.

Further, as per Article 163(2), if any question arises whether the matter falls under the discretionary power of the Governor or not, the decision of the Governor shall be final in this regard. Also, the validity of anything done by the Governor shall not be called in question on the ground that he ought or ought not to have acted in his discretion

Also, on lines of Art. 74(2), as per Article 163(3), the question cannot be raised in any court on what advice was tendered by Ministers to the Governor.

If we compare the provisions of Article 74 and 163, which talk about the position of President and Governor vis-à-vis their respective Council of Ministers, then we identify the following differences:

- Article 163(1) recognises that there are functions which the Governor is required to exercise in his discretion.
- 2. The 42nd amendment act added the clause 'who shall act in accordance with such advice' in Article 74(1). Thus, it was clearly spelt out that the President shall act according to the aid and advice of the Union Council of Ministers. However, no such insertion was made in Article 163(1), thus the scope for Governor's discretion was not reduced.
- 3. Article 163(2) clarifies that if any question arises whether the matter falls under the discretionary power of the Governor or not, the decision of the Governor shall be final in this regard.

Instructions required from President to promulgate ordinance on following matters

Governor cannot make an ordinance without the instructions from the President in three situations. To put in another way, Governor can promulgate ordinance in the following three situations only on the instructions of the President

- (a) A Bill containing the same provisions would have required the previous sanction of the President for its introduction in the State Legislature
- (b) He would have deemed it necessary to reserve a Bill containing the same provisions for the consideration of the President
- (c) An Act of the Legislature of the State containing the same provisions would have been invalid unless, the act had been reserved for the consideration of the President, and it had received the assent of the President.

Power of an Ordinance

An Ordinance shall have the same force and effect as an Act of State Legislature. Thus, an ordinance has same power as that of a law passed by the State Legislature. This has two implications:

The fundamental duties are applicable only to the citizens (not all individuals) of India. Thus, these duties are not applicable to foreigners in India.

Administration of Scheduled Areas

As mentioned above, the Administration of Scheduled Areas is undertaken as per the Fifth Schedule of the Constitution. The Provisions of this Schedule are as follows:

1. Scheduled Areas

In this Constitution, the expression "Scheduled Areas" means such areas as the President declare by order to be Scheduled Areas.

Thus, the constitution authorizes the President to declare an area as Scheduled Area. At present (2023), the President has declared the Scheduled areas in 10 States. These States are Andhra Pradesh, Telangana, Jharkhand, Chhattisgarh, Gujarat, Himachal Pradesh, Madhya Pradesh, Maharashtra, Odisha and Rajasthan.

Further, the President is authorized to pass order increase or decrease a Schedules area, rectify the boundaries of a Scheduled area, rescind designation of a Scheduled Area or redefine an area to be Scheduled Area.

However, the President can pass order to increase a Schedule Area or redefine a Scheduled Area only in consultation of the State Governor concerned.

2. Executive Power over Scheduled Areas

The State government enjoys the Executive power over the Scheduled Areas. Further, The Governor of each State having Scheduled Areas is required to report to the President regarding the administration of the Scheduled Areas. Such a report is submitted to the President either annually, or whenever so required by the President. The Union go PrepMate dAS give directions to the State as to administration of Scheduled Areas.

4. Law applicable to Scheduled Areas

The Governor of a State may by public notification direct that any particular Act of Parliament or of the Legislature of the State shall either not apply or apply with modifications to a Scheduled Area or any part thereof. Such a public notification may even have retrospective effect (effect from back date).

Also, Governor of a State may make regulations for the peace and good government of any Scheduled area in a State. Among other provisions, such regulations may cover the following matters:

- (a) prohibit or restrict the transfer of land by or among members of the Scheduled Tribes;
- (b) regulate the allotment of land to members of the Scheduled Tribes;
- (c) regulate the business of money-lending by persons who lend money to the Scheduled Tribes.

In order to make such regulations, the Governor may repeal or amend any Act of Parliament or of the State Legislature. The regulations made by Governor are submitted to the President. Such regulations do not come into effect without the assent of the President.

It is mandatory on the Governor to consult State Tribes Advisory Council for making such regulations.

These exceptions are given under Article 361 of the Constitution in respect of President and Governors: 1. The President or Governor is not answerable to the Court of Law in exercise of his or her executive powers. This exception is given because the President or Governor acts on the advice of the respective Council of Ministers.

- 2. No criminal proceedings can be undertaken against the President or Governor while they are in office. This is inspired from the maxim "rex non potest peccare", which means that the king can do no wrong. In the Indian context, it is applied to maintain the sanctity of the office and avoid undue pressure on the President or Governor while discharging their duties. However, it does not mean that the President or Governor is above law. Criminal proceedings are undertaken against the president or governor after their removal from office.
- 3. No civil proceedings can be initiated against the President or Governor without giving prior notice of two months. Civil proceedings against the President or Governor may generate pressure on them and hamper their functioning. Thus, a time period of two months is given for an adequate preparation to face civil proceedings.

State Legislature Privileges

The Constitution extends the Parliamentary Privileges to State Legislatures, their committees and their members by incorporating Article 194 in the Constitution. In other words, the State legislatures, their committees and their members enjoy the same privileges as those enjoyed by the Parliament, its committees and its members respectively.

Article 194 extends these privileges to persons who have right to speak and take part in parliamentary proceedings. Thus, these privileges are also available to Advocate General and State Ministers.

However, these privileges are not applicable to Governor, though he is an integral part of State Legislature.

Sources of Parliamentary Privileges

Article 194 of the Constitution expressly mentions two privileges:

- 1. Freedom of speech and vote to members of Parliament
- Right of publication of its proceedings

Apart from these two privileges, the original constitution provided that the other privileges were to be the same as those enjoyed by the British House of Commons, its committees and its members on the date of the commencement of the Constitution (i.e., 26 January 1950), until the Privileges are defined by State Legislature.

of Asia and one of the largest in the world, the Banaras Hindu University (BHU). For almost two decades he served as Vice Chancellor of the BHU.



He was a proponent of Hindu nationalism and remained a member of Hindu Mahasabha. He founded the Ganga Mahasabha in Haridwar. Malviya founded Ganga Mahasabha to oppose the dam construction over Ganga. He compelled the British Government to sign an agreement with Ganga Mahasabha and other Hindu religious leaders on uninterrupted flow of Ganges in Haridwar. This agreement is known as Aviral Ganga Raksha Samjhauta 1916 also known as Agreement of 1916.

Malaviya and other imminent Indian personalities established 'Scouting in India'. Scouting is the action of gathering information about enemy forces or an area.

He was an avid journalist and writer, he launched a Hindi language weekly, the Abhyudaya, in 1907, and an English newspaper, The Leader in 1909, as well as a Hindi monthly magazine called Maryada in 1910. He was the chairman of the board of Hindustan Times from 1924 to 1946, and facilitated the launch of its Hindi edition in 1936.

To dedicate fully to the cause of social work and education, Malaviya relinquished his well set up law practice in 1911 and vowed to lead a life of a Sanyasi. However, in 1924, following the Chauri-Chaura incident of 1922 he appeared before the Allahabad High Court to defend the 177 freedom fighters, who were sentenced to be hanged by the Sessions Court and became successful in getting 156 acquitted.

In 1912, he became a member of the Imperial Legislative Council and remained its member (even after it was transformed in 1919 into the Central Legislative Assembly) till 1926. He also published a manifesto insisting to concentrate on the 'Buy Indian' movement in the country.

People used to address him as Pandit Madan Mohan Malaviya out of respect. He was conferred many titles—Rabindranath Tagore gave him the title 'Mahamana', Mahatma Gandhi called him a 'Pratah Smaraniyah' and 'Devata Purush'. He popularised the slogan 'Satyameva Jayate' (Truth alone will triumph) from the Mundak Upanishad expressing that it should be the slogan for the country.

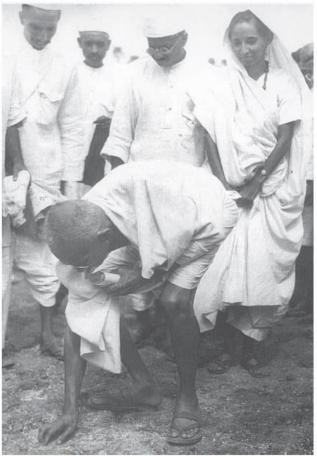
Disenchanted with the 'Communal award', he split from the Congress along with Madhav Shrihari Aney and the duo founded Congress Nationalist Party in 1934. That year the party

DANDI MARCH/SALT SATYAGRAHA (12 MARCH 1930-5 APRIL 1930)

Mahatma Gandhi, with his chosen 79 followers, started the Dandi March from Sabarmati asharam till the coast of Dandi, Gujarat. He reached the coast of Dandi on 5 April 1930 after marching a distance of 200 miles and on 6 April formally launched the Civil Disobedience Movement by breaking the salt laws.

Brahmo samaj

Brahmo Samaj was started in Calcutta on 20 August 1828 by Raja Ram Mohan Roy and Debendranath Tagore for reformation of the prevailing Brahmanism of the time.

Raja Ram Mohan Roy is considered as the first modern man of India as he initiated social reform movements in modern India. Raja Ram Mohan Roy is also regarded as 'the bridge between the past and the future'.

Atmiya sabha

Atmiya Sabha was a philosophical discussion circle. The association was started by Ram Mohan Roy in 1815 in Kolkata to conduct discussion sessions on philosophical topics. The association was also used to promote free and collective thinking and social reform. The foundation of Atmiya Sabha is considered as the beginning of the modern age in Kolkata. However, the association became defunct in 1823.

NON-COOPERATION MOVEMENT

Non-cooperation Movement was launched on 1 August 1920 to fulfill two major demands:

- 1. Redressal of Jallianwala Bagh wrongs
- 2. Khilafat issue

Mahatma Gandhi laid elaborate program for Non-cooperation Movement. The program was twin- fold: positive and negative.

The negative program included boycott of titles, offices, schools, colleges, foreign goods, refusal to join military services, etc. Triple Boycott emerged as the most popular form of boycott comprising of boycott of elections, legislatures and courts.

The positive program included setting up of national educational institutions, popular courts, Charkha and Khadi popularization, raising volunteer cops, etc. Charkha was considered a symbol of self-reliance as Indians were able to produce their own cloth and were not

Spread of the Movement

Gandhiji and Ali brothers undertook a nation-wide tour. About 90,000 students left government schools and colleges, many lawyers gave up their practice, boycott of foreign cloth was practised and foreign cloth was even publicly burnt.

Shops selling liquor were picketed. Tilak Swaraj fund was oversubscribed. Ali brothers gave message to resign from the army but were arrested. However, Mahatma Gandhi continued to disseminate the message of Ali Brothers.

Some local Congress committees also gave call for Civil Disobedience Movement. Civil Disobedience Movement was organized at Midnapore in Bengal and at Guntur in Andhra Pradesh by non-payment of land revenue. Strikes were organized in Assam tea plantations and steamer services. The spirit of defiance led to local struggles such as Avadh Kisan Sabha Movement, Mappilla movement, Praja Mandal movement and SGPC movement.

Calcutta Session of Congress, September 1920

Calcutta Session was presided over by Lala Lajpat Rai. This session was held to approve the Non- Cooperation Movement. Gandhiji wrongly predicted the attainment of Swaraj within a year of launching Non-Cooperation Movement. His opinion was rebutted by C.R. Das and the resolution was not approved. Before this, On 1 August 1920, Gandhiji launched the Non-Cooperation Movement. On the same day, Bal Gangadhar Tilak died.

Nagpur Session, December 1920

In Nagpur Session, the resolution for Non-Cooperation Movement was approved and Congress emerged as a full-fledged political party because of the following reasons:

- 1. The organizational structure of Congress was laid down. Four-tier executive structure was adopted. All India Congress Working Committee was constituted as the central executive body, provincial or pradesh Congress committee was constituted as an executive body at provincial level, district Congress committees and taluka Congress committees were also set up. All India Congress Working Committee was to take directions from All India Congress Committee which was responsible for policy making and overall direction of the Congress.
- 2. Membership fee was prescribed at four anna.
- Code of Conduct was laid down for the members of Congress which included Swadeshi hand spinning for production of cloth, Removal of untouchability, Hindu-Muslim unity, promotion of Hindi as national language, etc.
- The goal of Congress was defined as attainment of Swaraj which Gandhiji interpreted as self- government either within or if possible even outside the British Empire.

Due to increased pressure on Mahatma Gandhi, he threatened British with Civil Disobedience Movement unless political prisoners are released and press controls are removed.

Fa-Hien (c. 337-422)

Fa-Hien (also known as Faxian) was a Chinese pilgrim, who visited India during the reign of Chandragupta II. He came to India by the land route through North-West India. He visited Peshawar, Mathura, Kannauj, Sravasti, Kapilavastu, Kusinagara, Pataliputra, Kasi, and Bodh Gaya among other places. He returned by the sea route, visiting on the way Ceylon (present-day Sri Lanka) and Java (Island of Indonesia). The main agenda of his visit was to know about origins of Buddhism and to collect Buddhist manuscripts from India.

He stayed in India for 9 years. Out of this stay, he spent 6 years in the Gupta Empire including 3 years stay in Pataliputra for studying Sanskrit and copying Buddhist texts.

His account provides the following information:

- Religion: Fa-Hien's primary interest was religion. He assessed everything from the angle of Buddhism. The popular religions at that time were Buddhism and Hinduism. Hinduism was popular in North India, whereas Buddhism was flourishing in Western India. He even mentions about unsatisfactory state of some of the Buddhist holy places like Kapilavastu and Kusinagara in North India.
- **Politics:** Fa-Hien did not even mention the name of Chandragupta II in his account. He was not interested in political affairs. However, it can be inferred from his account that the Gupta rulers were tolerant toward other religions. Economic condition of the empire was prosperous.
- Administration: Fa-Hien characterizes the Gupta administration as kind and benevolent. There were no restrictions on movement of people. People enjoyed a large degree of

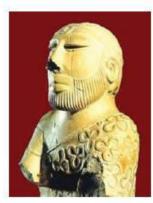

The line was established by international agreement in 1884 at a conference held in Washington D.C. The Line is not a straight line, but rather zigzags around various island groups and territories in the Pacific Ocean in order to avoid splitting them into two different calendar days. For instance, the International Dateline zigzags from 180° meridian at the Bering Strait, Fiji and other islands so that it does not cross from them. If IDL in the mid pacific would have been straight, then it would have crossed from the centre of the islands located in Pacific Ocean and caused confusion of date in these islands. Moreover, in order to avoid confusion of date, some countries choose to observe the same calendar day across the entire country, regardless of where they fall on the line.

It occurs due to massive discharges of electromagnetic radiations from the atmosphere of the Sun. Flares arise when the Sun's powerful magnetic fields become excessively entangled. Like a rubber band snaps after it is too much twisted, the magnetic fields that become excessively entangled release energy when they break. The energy emitted by a solar flare is more than one million times as that of a volcanic eruption on Earth!

Sol. (c) This question can be handled through conventional Geography. To answer this question, we need to determine accuracy of Statements II and III. As statement II is incorrect, the answer is option (c).

• **Solar Prominences**: A solar prominence is a big, luminous structure that protrudes from the Sun's surface. These protrusions originate in the photosphere and extend into the corona (the Sun's outer atmosphere). When stable, a prominence can persist for several months and extend thousands of kilometres into space.

Solar Prominence is composed of Plasma, a mixture of charged hydrogen and helium particles in a heated, gaseous state. Solar Prominence gets its meandering shape under the influence of the Sun's magnetic field.

The primary distinction between solar prominences and solar flares is that solar prominences do not pose a threat to Earth.

A solar prominence remains within the Sun's magnetic field, whereas a flare escapes the Sun's grasp and disperses waves throughout the solar system.

• **Solar Winds**: The Solar Winds are a constant flow of charged particles from the corona, the sun's outermost atmosphere. These charged particles travel through the solar system at speeds between 400 and 800 kilometers per second.

When the solar winds reach Earth, charged particles are deflected towards the poles (of Earth) by our planet's magnetic field. These charged particles also interact with the layer of upper atmosphere called ionosphere. The interaction of these particles with ionosphere produce aurora displays over polar regions.

So, Statement II is correct but doesnot explain Statement I.

Statement III: As the Earth's polar ice melts, the water tends to move towards the equator. Melting polar ice redistributes mass from the poles to lower latitudes (closer to the equator). This shift in mass affects Earth's moment of inertia, leading to changes in its rotation and axis — similar to a figure skater extending their arms.

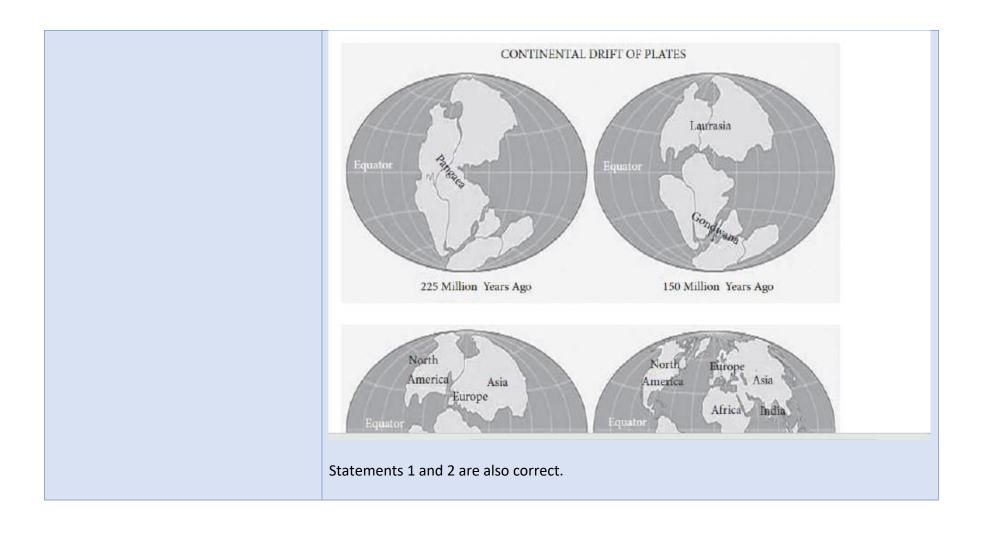

Monsoon

Monsoon refers to the "seasonal reversal in the direction of winds". In other words, winds that change their direction with the change in seasons are called Monsoon. Monsoon winds arise on account of differential heating of land and water.

Differential heating of land and water arises because the specific heat capacity of water is higher than the specific heat capacity of land. Thus, more heat is required by water, as compared to the heat required by land to raise its temperature. Also, once heated, water takes longer time to release heat. Thus, the variability of temperature is higher on land than on a waterbody.

In summers, the temperature on land is higher than the temperature at sea; thus, a low-pressure belt emerges over land and winds blow from sea to land. Consequently, moisture-laden winds blow from sea towards land and thus bring rainfall over land.

In winters, land is colder than sea. A low-pressure belt emerges over sea and thus winds blow from land to sea. These winds are dry and thus do not bring rainfall over land or sea.

The black soils are generally clayey, deep, and impermeable. These soils swell and become sticky when wet and shrink when dried. So during the dry season, the soil develops wide cracks. Thus, there occurs a kind of "self-ploughing".

The black soil absorbs moisture, which evaporates from the soil at a very low rate. Because of this character of slow absorption and loss of moisture, the black soil retains moisture for a very long time. This moisture helps crops, especially the rain-fed ones, to sustain even during the dry season.

HEAT BUDGET OF THE EARTH

The Earth receives all its heat in the form of insolation from the Sun. The heat received by the Earth in the form of insolation is reflected back in the form of terrestrial radiation.

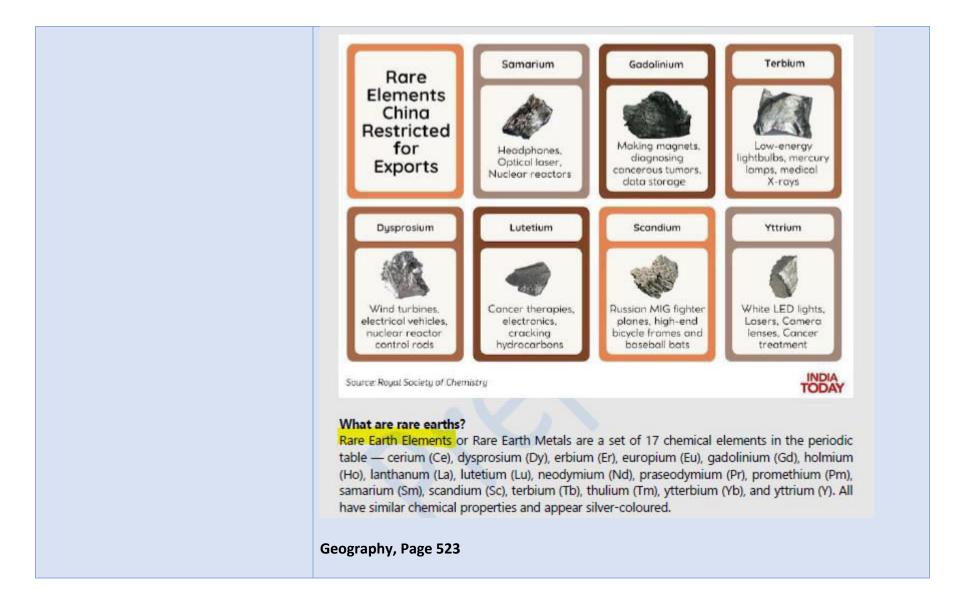
Of the 100 insolation units received from the Sun, 35 units are reflected back to space. The remaining 65 units are absorbed—14 units within the atmosphere and 51 units by the Earth's surface. Of the 35 units reflected back to space, 27 units are reflected back from the clouds.

The Earth radiates back 51 units in the form of terrestrial radiation. Of these 51 units, 17 units are directly radiated back to the space and the remaining 34 units are absorbed (19 through latent heat of condensation, 9 via convection, and 6 on account of direct contact) by the atmosphere.

The atmosphere radiates back 48 units (34 units received from the Earth and 14 units directly absorbed from insolation).

Thus, there is continuous inflow and outflow of heat on the Earth. Global warming occurs on account of increasing concentration of greenhouse gases such as CO2, which trap the terrestrial radiation and prevent it from going outside into the space.

Detailed Uses

Cerium, lanthanum, and neodymium have a multitude of applications. They serve as valuable glass additives in optical lenses and display screens, act as catalysts in automotive systems to reduce sulfur dioxide emissions, and find use in multilayer capacitors. When combined with yttrium, they become essential components in magnesium, aluminum, and hydrogen storage alloys. Mischmetal, an alloy of cerium with small quantities of other rare earth metals, is employed in various applications, including lighter flints, desulfurization in steel and foundry processes, and, when blended with lanthanum alloys, in batteries and hydrogen storage systems designed for electronics and hybrid vehicles. Cerium oxide plays a pivotal role in the glass polishing industry.

Lanthanum oxide and neodymium compounds are integral to the production of specialized glass. Lanthanum is employed in X-ray films as phosphors, while yttrium contributes to advanced ceramics, such as nitrides and Y-stabilized ceramics. Gadolinium is a key component in magnet alloys, while yttrium, europium, and terbium function as phosphors in computer and TV displays. These elements, in conjunction with lanthanum, cerium, and gadolinium, also serve as phosphors in fluorescent and halogen lamps.

CAPITAL MARKET

A capital market is a financial market where exchange of funds is for a period of 1 year or more. Various capital market instruments are as follows:

- Long-term loans: These loans are taken for a period of more than 1 year.
- **Shares:** A share is one of the equal parts into which a company's capital is divided, entitling the holder to a proportion of the profits. Shareholders are owners of the company. Shares are of two types: equity and preference.

Equity shareholders are given share out of profits or repayment of capital on liquidation only after settling the claims of preference shareholders. Thus, they are the primary risk bearers in the company.

Preference shares are called so because their claim in profits and repayment of capital on liquidation is settled before payment is made to equity shareholders.

- **Debentures:** These refer to the unit of debt or loan. Debentures are issued at a fixed rate of interest by the company. Debenture holders are the lenders of the company. The interest on debenture is required to be paid even if the company suffers losses.
- **Bonds:** Bonds, like debentures, carry fixed rate of interest. Usually bonds are issued by the government to collect money to carry out its expenditure. For example, the Government of India launched infrastructure bonds to raise funds for infrastructure development in India.

Venture Capital

Venture capital refers to finance provided by investors to start-up companies and small businesses that are believed to have long-term growth potential. For start-ups without access to capital markets, venture capital is an essential source of money. Risk is typically high for investors, but the potential for above-average returns is an attractive payoff.

Venture capital does not always take a monetary form; it can be provided in the form of technical or managerial expertise. For new companies or start-up ventures that have a limited operating history, venture capital funding is increasingly becoming a popular capital raising source, as funding through loans or other debt instruments is not readily available.

The RBI is an independent apex monetary authority that also regulates banks and provides important financial services such as storage of foreign exchange reserves, availability of credit, accept deposits from government and banks. Specifically, the RBI performs the following important functions:

 Issue of bank notes: The RBI has the sole right to issue currency notes except one-rupee notes, which are issued by the Ministry of Finance.

This function of the RBI has a number of advantages: (i) it brings uniformity in issue of notes; (ii) it makes possible effective state supervision; (iii) it is easier to control and regulate credit in accordance with the requirements in the economy.

2. Banker to the government: As banker to the government, the RBI manages the banking needs of both Central and State Governments. It has to maintain and operate the government's deposit accounts. It collects receipts of the funds and makes payments on behalf of the government. It issues and manages government securities. It represents the Government of India as the member of the IMF and the World Bank.

- **3. Custodian of cash reserves of commercial banks:** The commercial banks hold deposits in the Reserve Bank, and the latter has the custody of the cash reserves of the commercial banks.
- **4. Custodian of country's foreign currency reserves:** The Reserve Bank has the custody of the country's reserves of international currency, and this enables the Reserve Bank to deal with crisis connected with adverse balance of payments position.
- **5. Lender of last resort:** The commercial banks approach the Reserve Bank in times of emergency to tide over financial difficulties, and the Reserve Bank comes to their rescue though it might charge a higher rate of interest.
- **6. Central clearance and accounts settlement:** Since commercial banks have their surplus cash reserves deposited in the Reserve Bank, it is easier to settle the claim of these banks on each other through entries in the books of the Reserve Bank. The clearing of accounts has now become an essential function of the Reserve Bank.
- **7. Controller of credit:** Since credit money forms the most important part of supply of money, and since the supply of money has important implications for economic stability, the importance of control of credit becomes obvious. Credit is controlled by the Reserve Bank in accordance with the economic priorities of the government.
- **8. Regulator of banks and non-banking financial companies:** Opening a bank or a non-banking financial company (NBFC) requires a license from the RBI. It ensures that financial interest of the depositors is not hampered. It also keeps checks that the banks and NBFCs adhere to capital adequacy norms, etc.

Difference between Bonds and Debentures

Debentures and bonds are types of debt instruments that can be issued by a company. In some markets (India, for instance), the two terms are interchangeable, but in the United States, they refer to two separate kinds of debt-based securities.

Debentures have a more specific purpose than bonds. Both can be used to raise capital, but debentures are typically issued to raise short-term capital for upcoming expenses or to pay for expansions.

Another important difference is that debentures are never asset backed (they are not secured by any collateral) and are only backed by the credit of the issuer. On the other hand, bonds are secured by particular collateral.

Criticism of IMF

Real Time Gross Settlement (RTGS)

RTGS was introduced by the RBI in 2004. RTGS system, as the name indicates, involves settlement of transactions in "real time" and on a "gross" basis. RTGS is called a "Real Time" system as the transactions are processed at the exact time as and when they are received. RTGS is also called a "Gross Settlement" system because the transactions are processed on a one-on-one basis and are not bundled with other transactions as in the case of NEFT.

The minimum transfer limit for RTGS is Rs. 2 lakh whereas there is no maximum transfer limit. Therefore, for transfer of large funds of Rs. 2 Lakh and above, RTGS is the preferred system. Like Immediate Payment Service (IMPS) and NEFT, it is also available round the clock.

Statement 2 is incorrect: With effect from July 01, 2019, RBI has waived the processing charges levied by it for RTGS transactions. Banks may pass on the benefit to its customers. NEFT does not levy charges for inward transactions, i.e., when funds are credited to the beneficiary's account. This makes it cost-effective for receiving money while RTGS is chargeable for most customers.

What Is Cloud Seeding?

Seeding involves spraying chemicals into clouds. Cloud seeding is a form of weather modification. It is a way of changing the amount or type of precipitation that falls from clouds, by dispersing substances into the air that serve as cloud condensation or ice nuclei, which alter the microphysical processes within the cloud. The usual intent is to increase precipitation (rain or snow), but hail and fog suppression are also widely practiced in airports.

How Does It Work?

The most common chemicals used for cloud seeding include silver iodide, potassium iodide and dry ice (solid carbon dioxide). Liquid propane, which expands into a gas, has also been used. This can produce ice crystals at higher temperatures than silver iodide. After promising research, the use of hygroscopic materials such as table salt, is becoming more popular.

Introduction of a substance such as silver iodide, which has a crystalline structure similar to that of ice, induces freezing nucleation (molecules gathering in clusters). In mid-latitude clouds, the usual seeding strategy has been based on the fact that the equilibrium vapour pressure is lower over ice than over water. The formation of ice particles in super-cooled clouds allows those particles to grow at the expense of liquid droplets. If sufficient growth takes place, the particles become heavy enough to fall as precipitation from clouds that otherwise would produce no precipitation. This process is known as 'static' seeding.

Beginning of Cloud Seeding

China used this technique during the 2008 Olympics to steer rain away from the inaugural venue and now it has a full-fledged department that blasts rockets into clouds to induce rain and control pollution.

Originally formed as BIST-EC (Bangladesh, India, Sri Lanka and Thailand Economic Cooperation) in 1997, it became BIMST-EC after Myanmar joined, and BIMSTEC in 2004 with Nepal and Bhutan.

WHAT IS THE AIM BEHIND BIMSTEC?

For one, it provides a common platform for countries in South Asia and Southeast Asia at a time when the SAARC is more or less defunct. While the Association of Southeast Asian Nations (ASEAN) is seen as one of more cohesive groupings in the world, the lack of forward movement in the fraught India-Pakistan relationship has left few options for South Asian countries. Landlocked countries, Nepal and Bhutan, may also benefit from access to the Bay of Bengal as a result of better ties with BIMSTEC countries.

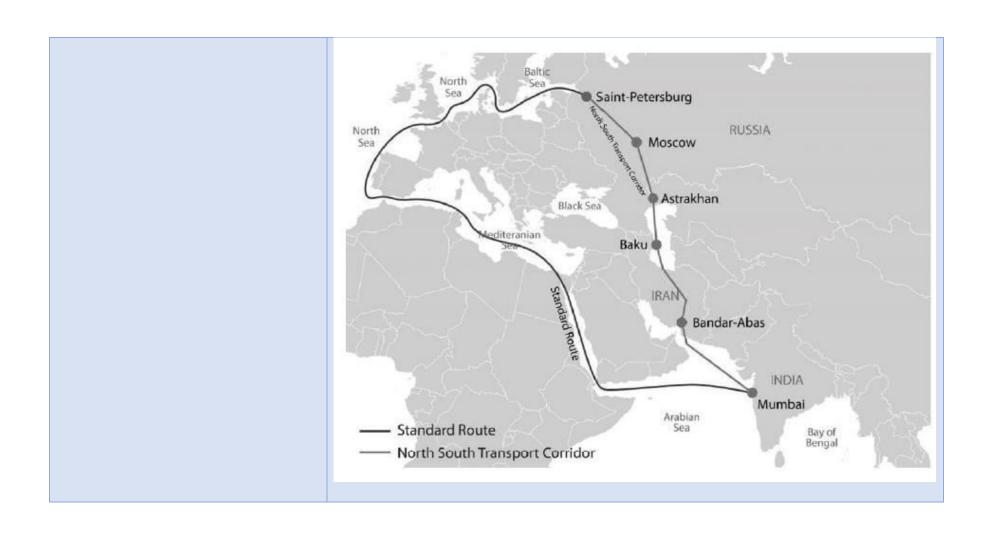

an engine. The term Electric Vehicle is generally used to refer to a Battery Electric Vehicle.

The conventional vehicles use combustion of fossil fuels to generate the energy needed to power the engine. The combustion of fossil fuels releases pollutants and GHGs. Electric vehicles, on the other hand, are environment friendly as they are emission-free. Moreover, since electric vehicles do not generate emissions, there are no carbon deposits on their parts. Thus, unlike fossil fuel-based vehicles, electric vehicles do not require regular service, and hence, their maintenance cost is negligible.

Unlike, the internal combustion engine of conventional vehicles, electric vehicles have an electric motor. This electric motor drives the wheels of the vehicle. The vehicle consists of a battery pack that can be charged by plugging into a charging outlet. The battery powers the electric motor.

Hydrogen cars or Fuel cell electric cars

Hydrogen cars are also known as fuel cell electric cars. These vehicles use hydrogen as fuel to generate electricity. The electricity is used to power the electric motor of the car. A major difference between electric vehicles and hydrogen cars is that while electric vehicles use electricity from an external power source (battery is charged by plugging into an outlet), hydrogen cars generate their own electricity. They are called fuel cell electric vehicles to differentiate them from the regular Battery Electric Vehicles (BEVs).

Hydrogen cars use fuel cell technology to generate electricity. The hydrogen fuel in the tank reacts with oxygen from the air. The reaction takes place inside a fuel cell. As a result of this chemical reaction, electric energy is produced along with heat and water. Hence, water vapour is emitted as a by-product. The electricity generated is used to power the electric motor in the vehicle. Alternatively, hydrogen cars can also be equipped with a battery (called Peak Power battery), which is charged by the electricity from the fuel cell. Compared to batteries in electric vehicles, peak power batteries are smaller and lighter.

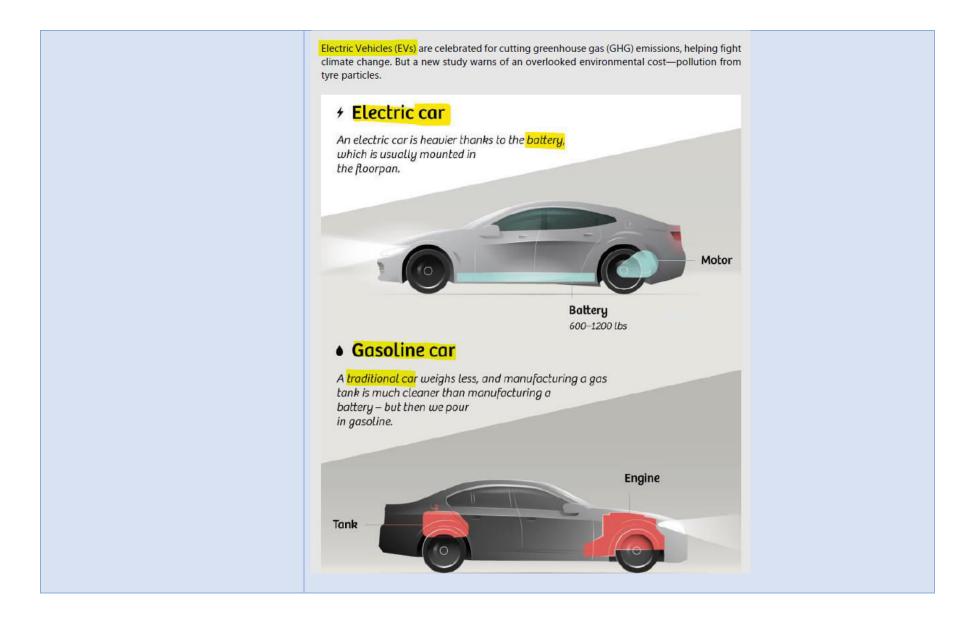

How do hydrogen fuel cells work?

A hydrogen fuel cell generates electricity by utilising the chemical energy contained in hydrogen. It releases only pure water, not discharging pollutants. Hydrogen is loaded into cells. The energy within the hydrogen is converted into electricity and heat, which is then used to power the vessel's propulsion mechanism. In the fuel cell, the hydrogen reacts with the oxygen in the air to produce electricity. Unlike batteries, hydrogen fuel cells do not require recharging. Provided uninterrupted supply of fuel and oxygen, these cells would work continuously.

GAGAN system is also interoperable with other international Satellite-based Augmentation Systems (SBAS), and hence can provide seamless navigation across the regional boundaries. The Signal-In-Space (SIS) of GAGAN system is available through the satellites-GSAT-8, GSAT-10, and GSAT-15.

According to ISRO, GAGAN though primarily meant for aviation, will provide benefits beyond aviation to many other user segments such as intelligent transportation, maritime, highways, railways, survey- ing, geodesy, security agencies, telecom industry, personal users of position location applications, etc.

What is the new proposed highway tolling system?

The global navigation satellite system is a term used to refer to any satellite-based navigation system, including the United States' Global Positioning System (GPS). It uses a large constellation of satellites to provide more accurate location and navigation information to users globally as compared to the GPS alone.

An official of the Ministry of Road Transport and Highways explained that its implementation will involve an On-Board Unit (OBU), or a tracking device, fitted inside a vehicle whose location can be mapped using GAGAN, the Indian satellite navigation system with an approximate accuracy of 10 metres. The co-ordinates of the entire length of the country's national highways will have to be logged with the help of digital image processing, and software will be used to assign the toll rate on a particular highway, calculate the toll amount for a vehicle as per the distance travelled by it and then deduct it from a wallet linked to the OBU.

The Ministry official further explained that the aim of the technology is to provide users the benefit of paying toll only for the actual distance travelled on a highway, or pay-as-you-use. The government also hopes that it will eventually allow barrier-free movement.

Enforcement Directorate (Directorate General of Economic Enforcement)

The Directorate General of Economic Enforcement is a law-enforcement agency and economic intelligence agency responsible for enforcing and fighting economic crime in India. It is a part of the Department of Revenue, Ministry of Finance. It comprises officers of the Indian Revenue Service, Indian Police Service, and the Indian Administrative Service.

It was set up in 1956 to deal with foreign exchange violations under the Foreign Exchange Regulation Act, 1947. Presently, the prime objective of the Enforcement Directorate is the enforcement of two key acts of the Government of India: the Foreign Exchange Management Act (FEMA) 1999 and the Prevention of Money Laundering Act (PMLA) 2002.

The Fugitive Economic Offenders Act (FEOA), 2018 is an Act of the Parliament of India. Under this act, a court (declared as 'Special Court' under the Prevention of Money Laundering Act, 2002) can declare a person as a Fugitive Economic Offender if the following two conditions are fulfilled:

- 1. The value of offences by a person exceeds Rs. 100 crore and an arrest warrant has been issued against the person.
- 2. The person has escaped from India and refuses to return to face prosecution.

Once a person has been declared fugitive economic offender (FEO), a special FEOA court can order the confiscation of his/her properties, including those which are benami, both within and outside India. Once properties are confiscated, the Union government has the right over them, and it can dispose them after 90 days.

Rashtriya Gokul Mission was launched in December 2014 for the conservation and development of indigenous breeds. The mission was launched under the Department of Animal Husbandry, Dairying & Fisheries (Union Minister for Agriculture & Farmers' Welfare). However, after formation of separate ministry of Ministry of Fisheries, Animal Husbandry and Dairying, the mission has been assigned to it.

Under this scheme, proposals from states for the conservation and development of indigenous breeds are approved and the funds are provided for these proposals. Among other initiatives, Rashritya Gokul Mission also includes setting up of Gokul Gram. These Gokul Grams are Centres for development of indigenous breeds.
